1. INTRODUCTION

The **Crimean Human Rights Group (CHRG)** is an organization of the Crimean human rights defenders and journalists, the purpose of which is to promote the observance and protection of human rights in Crimea by attracting widespread attention to the problems of human rights and international humanitarian law in the territory of the Crimean peninsula, as well as the search and development of mechanisms to protect the human rights in Crimea.

The **CHRG** first of all obey the rules of basic documents in the field of human rights, such as: the Universal Declaration of Human Rights, the Helsinki Final Act, the Convention on the Protection of Human Rights and Fundamental Freedoms, the International Covenant on Civil and Political Rights, the International Covenant on economic, social and cultural Rights and others.

The main objectives of the CHRG:

- 1) Collection and analysis of the information regarding the human rights situation in Crimea;
- 2) Broad awareness among governments, international organizations, intergovernmental organizations, non-governmental organizations, the media and other target groups through the publication and spreading of analytical and information materials on the human rights situation in Crimea;
- 3) Promote the protection of human rights and respect for international law in Crimea;
- 4) Preparation of recommendations for government authorities and international organizations in the sphere of human rights;
- 5) Providing the presence of "human rights in the Crimea topics" in the information space.

The **CHRG's** team consists of experts, human rights activists and journalists from different countries who are involved in monitoring and documenting human rights violations in Crimea, since February, 2014.

During preparation and spreading of the information the **CHRG** is guided by principles of objectivity, reliability and timeliness.

2. CIVIL AND POLITICAL RIGHTS

RIGHT TO LIBERTY AND SECURITY OF THE PERSON

SEARCHES AND DETENTIONS

On July 2nd the RF police detained **Mr. Seyyar Emirov** at his parents' house under RF CAO Article 20.29 (production and dissemination of extremist materials) (see Freedom of Speech and Expression section for detail).

POLITICALLY MOTIVATED CRIMINAL PROSECUTION

As at July 2019, **93 persons** are deprived from liberty within a politically motivated criminal and/or religious persecution. The full list is published at the CHRG website.¹

"CASE OF CRIMEAN MUSLIMS"

In July, the number of Crimeans deprived from liberty within the 'Case of Crimean Muslims' totaled **66 persons**.

Among them, 63 are charged with RF CC Article 205.5 (Organization of actions or participation in a terrorist organization), 2 - RF CC Article 282.2 (Organization of actions or participation in an extremist organization) and 1 - RF CC Article 205.2 (Public appeals to terrorist actions).

All defendants of this case are accused of relations with Islamic organizations or propagandizing the activities of 'Hizb-ut-Tahrir" and 'Tablighi Jamaat' — organizations declared terrorist or extremist in the RF though this is not the case according to the Ukrainian laws. Persecuting Ukrainian nationals on the occupied territory of Ukraine for membership in these organizations constitutes international human law norm violations.

On July 2nd Igor Kriuchkov, Anatoliy Osochenko, Yuriy LAtynin, and Timur Slezko, judges of 'the Supreme Court of Republic of Crimea' (hereinafter SCRC) upheld a decision on keeping in custody up to August 5th for **Riza Omerov, Eskender Suleymanov, Ruslan Mesutov, and Lenur Khalilov**².

On July 3rd Yelena Mikhal'kova and Mikhail Soboliuk, 'SCRC' judges, upheld a decision on keeping in custody up to August 5th for **Ayder Djapparov** and **Ruslan Nagayev**. Yuriy Latynin, a 'SCRC' judge, upheld a decision on keeping in custody up to August 9th for **Seyran Saliyev**³.

On July 4th Sergey Gorelov, a judge of the North Caucasus Area Military Court in Rostov-na-Donu (hereinafter NCAMC) extended a detention period for **Enver Seytosmanov**⁴. The lawyer informed that the detention period for Mr. Seytosmanov had been extended by 6 months —

till December 20th 2019. In addition, the judge made a decision on convoying Mr. Seytosmanov from Crimea to Rostov-na-Donu (RF)⁵. On July 28th the lawyer informed that **Enver Seytosmanov** had been convoyed from Simferopol to Rostov-na-Donu⁶.

On July 11th the RF Supreme Court in Moscow upheld verdicts of guilty for **Enver Mamutov, Zevri Abseitov, Rustem Abiltarov, and Remzi Memetov**. The court just reduced the sentence period by 3 months. Thus, Mr Enver Mamutov is sentenced to 16 years and 9 months, and the others to 8 years and 9 months in the maximum security regime colony⁷. When the case was being considered by the RF Supreme Court, the RF police detained activists who had come from Crimea to support the sentenced⁸.

On July 18th Andrey Paliy, a 'SCRC' judge, upheld a decision on detention for **Mr Osman Arifmemetov** till May 15th 2019. The first instance judgement had been made by 'Kievsky District Court of Simferopol' on March 28th 2019. On May 14th Kirovsky District Court of Rostov-na-Donu passed a judgement on extending the detention period for Mr Arifmemetov till August 15th. Thus, the 'SCRC' judgement was just for a procedure and had no impact on his detention⁹.

On July 23rd Yelena Spasenova and Anatoliy Osochenko, 'SCRC' judges, upheld a decision on detention till May 15th 2019 for **Mr. Seyran Murtaza and Mr. Izet Abdullayev**. At the moment of appealing against the detention, the detention periods for Mr. Murtaza and Mr. Abdullayev had been already extended, so the 'SCRC' judgement was just for a procedure¹⁰.

On July 24th Tatiana Mel'nik, and Alla Ovchinnikova, 'SCRC' judges, upheld a decision on detention till August 9th 2019 for **Mr Server Mustafayev and Mr Memet Belialov**¹¹. On July 25th the same judgement was passed by Natalia Cherevatenko, a 'SCRC' judge, for **Mr Timur Ibragimov**¹². Appeals were considered by the same court that had been the first instance court.

On July 25th the lawyer informed that **Mr. Arsen Abkhairov, Mr. Rustem Emiruseinov,** and **Mr. Eskender Abluganiyev** had been placed in the insane hospital for a compulsory psychiatric examination¹³.

On July 30th the lawyer informed that **Mr Izet Abdullayev**, **Mr Seytvel Seytatbiyev**, **Mr Akim Bekirov**, **Mr Alim Karimov**, and **Mr Asan Yanikov** had been convoyed from the Rostov-na-Donu (RF) Detention Center to the Simferopol Detention Center to be identified by a' secret witness'¹⁴.

On July 31st "Kievsky District Court of Simferopol' extended detention period for **Mr Enver Omerov, Mr. Riza Omerov, and Mr Ayder Djepparov** by 3 months — till November 5th 2019¹⁵. The judgement was passed by judge Olga Kuznetsova upon a request of Sergey Bosiyev, a RF FSB investigator¹⁶.

"UKRAINIAN SABOTEURS' CASE"

In July 13 people were accused by the RF FSB of 'preparing subversions and spying' when detained, were in custody: Yevgeniy Panov, Andrey Zakhtey, Vladimir Prisich, Vladimir Dudka, Dmitriy Shtyblikov, Aleksey Bessarabov, Gleb Shabliy, Aleksey Stogniy, Gennadiy Limeshko, Anna Sukhosova, Dmitriy Dovgopolov, Konstantin Davydenko, Yunus Masharipov. These cases feature recorded facts of unlawful investigation methods, torturing to get confessions, violation of presumption of innocence, dissemination of 'confession' videos by the FSB via the mass media.

Vladimir Dudka and Aleksey Bessarabov, sentenced unlawfully on April 4th 2019 to 14 years in the maximum security penal colony, are in the Simferopol Detention Center. The defence had appealed against the sentence, and the period for reviewing the case files within the appeal submitted expired in July.

"PERSECUTION FOR CHARGING WITH BEING IN N. CHELEBIDJIKHAN BATALLION"

The official reason for persecuting the people accused in Crimea under RF CC Article 208-2 (organization of an unlawful military unit or participation in it) is that they failed to come voluntarily to the RF law enforcement bodies and declare their participation in the Crimean Tatar Noman Chelebidjikhan Volunteer Batallion. The evidence of the battalion actions against the RF interests declared by the investigation is the information of mass media that the purpose of the battalion establishment was to de-occupy Crimea.

Given that a reason for persecution is a membership in the organization which purpose is to de-occupy Crimea and that is not involved in the armed conflict, the persecution as depriving from liberty may be considered a politically motivated persecution.

On July 12th Denis Didenko, a judge of "Kievsky District Court of Simferopol', passed a judgement on remanding in custody durante absentia for **Ms Gul'sum Khalilova**, an ATR Crimean Tatar TV Channel journalist.¹⁷

On July 30th Tatiana Doroshenko, a 'SCRC' judge, upheld a sentence for **Mr Edem Kadyrov** who had been sentenced to 4 years in the general regime penal colony on May 21st 2019 under the charge of being in the Chelebidjikhan Volunteer Batallion¹⁸.

The case of **Mr Diliaver Gafarov** charged with the same, is being heard in the 'Kirovsky District Court of Republic of Crimea'.¹⁹

VOLODYMYR BALUKH'S CASE

On July 2nd lawyer O.Dinze informed that the administration of Penal Colony No 4 (Torzhol) was planning to place **Mr.Volodymyr Balukh** as 'repeat violator' of the in-house rules into the ward type cell (WTC) where staying conditions were severer comparing to a standard cell.²⁰. According to the CHRG information, on July 3rd Mr.Balukh was moved to the WTC for 6 months.

On July 5th Mr Balukh stopped a hunger strike he had started on June 27th as protest against preventing the Ukrainian consul to meet with him. The Ukrainian stopped the hunger strike because the colony administration had satisfied his requirement and allowed the Ukrainian consul to see him²¹. However, the consult visited the activist not in his consul status but due to the prisoner's right to meet with the relatives. Thus, the Ukrainian consul is still prevented from visiting the Ukrainian national.

EDEM BEKIROV'S CASE

On July 3rd Mikhail Soboliuk, a 'SCRC' judge, upheld a decision on keeping **Mr Edem Bekirov** in custody till August 12th. The judgement was passed despite the health condition of Mr. Bekirov, a category 1 disabled person, that should not be kept in the detention facilities²².

CONFINEMENT CONDITIONS IN DETENTION FACILITIES

In the Simferopol Detention Center the detained are sick with measles. According to the activists' information, **Mr Edem Smailov**²³ and **Mr Memet Belialov**²⁴, 'Case of Crimean Muslims' defendants, are in the quarantine cell.

The number of the people deprived from liberty within the politically and religiously motivated persecution and detained in the Simferopol Detention Center totals at least 32.

On July 13th the lawyer informed that **Volodymyr Balukh** kept in the WTC in the Torzhok colony (RF) complained about a left leg edema, strong pain in joints and the chest²⁵. As at the end of July the colony administration did not satisfy his demand to be visited by an independent physician for diagnosing²⁶.

On July 16th Mrs Oksana Zakhtey, a spouse of **Mr Andrey Zakhtey**, a 'Case of Ukrainian Commandos' defendant, reported that in addition to the chronic gastritis and sinusitis the husband had a strong back pain, and joints on fingers swelled. Mr Zakhtey is kept in Colony no 1, Simferopol City²⁷.

On July 16th lawyer A.Ladin informed that **Mr Edem Bekirov** had been suffering of strong spasms and could not sleep due to this. His arrhythmia increased with the slightest physical effort. To keep a necessary sugar level in the blood he almost stopped eating²⁸. On July 22nd the lawyer informed that Mr Bekirov could not get up due to a pinched nerve in the vertebral column²⁹. In addition, as the relatives said, they could not transfer the necessary medicines he had been off to the medical unit.

The relatives of **Mr Vladimir Dudka** informed the CHRG that they could not still obtain the outcomes of the medical examination held last year. In addition, Mr Dudka has not even received any medical prescriptions after that examination.

FREEDOM OF SPEECH AND EXPRESSION

On July 2nd the Russian police detained **Mr Seyyar Emirov** at his parents' house. He was accused of placing a video 'Why Hizb-ut-Takhrir Is Blamed With Extremism' in VKontakte social network — under RF CAO Article 20.29 (*production and dissemination of extremist materials*) — that he did in 2013³⁰. The same day Yelena Sevriugina, a judge of 'Sudak Town Court', passed a judgment on imposing a RUR1,500 penalty on Mr Emirov³¹.

On July 11th Zoya Kurapova, a 'SCRC' judge, upheld a penalty of RUR1,000 imposed on activist Ms **Mumine Saliyeva.**³² The 'judge' denied taking photo and video during the session. Ms Saliyeva was fined under RF CC Article 203.1 *(public demonstration of extremist organization symbols)* for publishing the Hizb-ut-Takhrir party symbols in the social network in 2013, before the occupation of Crimea.

On July 24th 'Crimean Solidarity' activists reported that the RF police had called **Mr. Nuri Abdurashytov**, a 'Crimean Solidarity' activist and streamer, for interrogation due to his being on July 11th 2019 at the RF Supreme Court building in Moscow where an action for supporting the 'Case of Crimean Muslims' defendants had been held³³. On July 24th the Russian policemen came also to journalist **Emin Rustemov** to get his evidence³⁴.

FREEDOM OF THOUGHT, CONSCIENCE AND RELIGION

On July 5th the mosque in Zarechnoye Village of Simferopol District was searched³⁵.

On July 24th Archbishop Clement informed that all church objects of the Crimean Eparchy Administration had been stolen from the Cathedral of Sts Equal to Apostles Vladimir and Olga of the Orthodox Church of Ukraine under the pretext of repairs³⁶.

In July the CHRG recorded 3 new administrative cases under RF CoAO Article 5.26 (violation of laws on missionary activities) regarding the Crimean religious organizations and their members

3. VIOLATIONS OF INTERNATIONAL HUMANITARIAN LAW

GENEVA CONVENTION (III) RELATIVE TO THE TREATMENT OF PRISONERS OF WAR

In July the RF FSB brought a final indictment against 24 Ukrainian prisoners of war under RF CC Article 322.3 (*unlawful crossing of border*)³⁷.

On July 15th the RIA NOVOSTI Russian Information Agency reported, referring to the Lefortovo District Court, Moscow (RF), press office, that the RF FSB was requesting extending detention periods for the Ukrainian sailors for 3 months more³⁸. On July 17th Yelena Kaneva and Albina Galimova, judges of Lefortovo District Court, Moscow (RF), supported this request and extended the detention periods for Andrey Artemenko, Andrey Eyder, and Vasiliy Soroka till October 26th 2019, and other Ukrainian imprisoned sailors till October 24th 2019, cases nos 3/2-0279/2019³⁹, 3/2-0280/2019⁴⁰, 3/2-0281/2019⁴¹, 3/2-0282/2019⁴².

GENEVA CONVENTION (IV) RELATIVE TO THE PROTECTION OF CIVILIAN PERSONS IN TIME OF WAR

CONSCRIPTION OF PERSONS LIVING IN THE OCCUPIED TERRITORY INTO ARMED FORCES OF OCCUPYING POWER AND PROPAGANDA OF JOINING VOLUNTARILY THE ARMED FORCES

On July 5th INFORMER, a Sevastopol website, published a decision on starting a criminal case against Gleb Scherbakov, a Sevastopol resident, under RF CC Article 328 *(evasion of military service)* for refusing the military service and a letter of May 30th 2019 where Mr Scherbakov had explained his refusal by political opinions⁴³.

On July 22nd the website of 'Main Investigation Department of the RF Investigation Committee for Republic of Crimea' informed on starting a criminal case against a Sudak Town resident under RF CC Article 328.1⁴⁴.

In July the CHRG recorded 6 new criminal cases against the Crimeans for evading the RF Armed Forces military service and 5 new sentences: July 19th 'Kerch Town Court'⁴⁵ and 'Kirovsky District Court'⁴⁶, July 24th 'Dzhankoy Town Court'⁴⁷ and 'Sovetsky District Court'⁴⁸. Totally as at

the end of July the CHRG recorded 68 criminal cases for evading the RF Armed Forces military service that were sent to the Crimean 'courts' for considering. The judgements were passed on 64 of them, and 4 are still on consideration.

On July 28th when the day of the RF Navy was celebrated, there was a 'station for selecting to the contracted military service' at Nakimova Square in Sevastopol where the brochures advertising the services in the RF Armed Forces were distributed. In addition, the RF military men were instructing the children to use firearms.⁴⁹.
