**Organiser:** Crimea Platform Expert Network

## Goals:

- Assess the current situation in Ukraine as of the summer of 2024 and formulate a list of the most priority challenges
- To develop recommendations for further actions of the Network's experts and cooperation between the state authorities and the expert community for the liberation of the AR of Crimea with the subsequent establishment of sustainable peace and ensuring the implementation of international law
- Formulate recommendations to the Government of Ukraine and partner countries to increase pressure on Russia to reduce the aggressor's ability to finance the war
- Develop a vision for further support from partner countries to ensure a steady and rhythmic flow of resources, which will allow for longer planning periods
- Determine approaches to the recovery of Ukraine's economy in the face of a constant threat from Russia and its satellites
